Kevin W. overviewed Kevin K's email from the City of Deadwood to Northern Hills Rec. Comments were that the City met with the Conrad's and they are willing to write a check for \$7,500 (approximately half of Kevin Forrester's contracted amount to build in a 50" wide basic trail).

Jeff commented that we are all in agreement and all need to be on the same page that we (NHR) do not have the money to participate in moving a trail that we already legally have easement for. We (NHR) are content with it being relocated based on the GPS exhibits provided by Kevin Forrester and Ferber Engineering, but we do not have the funds to help. So others will need to step up to make this happen.

Additional comments were that we need to check with Homestake and/or Dakota Gold on the possibility of additional homestake land abutting Conrad's current parcel(s) being sold off to Conrad's. In our group's mind, it is almost irrelevant to relocate the trail off of Conrad property just for it to end up BACK ON Conrad property.

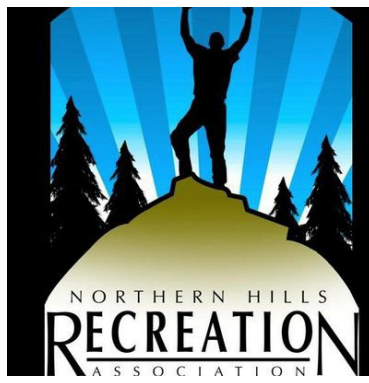
